- f) Costs for Village Grass Cutting Cllr. Gibbons reported that MK Watts will continue to cut the village Hall playing field for £100 per cut. Kavan of Buryhook Countryside Management has resigned. Cllr. Gibbons explained all the different cuts that Kavan has been doing to the Councillors and suggested that a local gardener be given the opportunity to quote and carry out the work for 6 months on a trial basis. The Clerk is to ask Lewknor Parish Council who they use.

- a) Drainage works under B4009, Aston Rowant & Aston Park Lake Cllr. Gibbons has met with David Baldwin who explained the new drainage works under the B4009 and the effects that it will have on the village.

### 12) FOOTPATHS AND AMENITIES

- a) Report from Cllr. P. Hetherington:
  - *i.* Progress of planting at Fiveways (FAAG)
    - 1. Planting is continuing. The next wild plants to be introduced will be primroses and after this year's flowering, bluebells will be planted (only the indigenous strain not Spanish). Mike Eaton has advertised on site for volunteers to help with the work and three new people offered their time.
    - 2. There has been no reply from Aston Rowant School as to whether they will participate in the project.
    - 3. Hazards have continued to be removed from the site, mainly remains of old metal fencing which could have caused accidents.
    - 4. County Council Countryside Services dug out the stream and introduced new drainage pipes under the bridleway in December which are working well and the better flow has flushed out a lot of silt. We now have to find a way of allowing fish to travel up the culverts and pipes.
    - 5. Research by the Eatons on old maps has revealed that the area used to be called Crossways not Five Ways. This is a more accurate description of the six paths and bridleways that converge near this point.
    - 6. Councillor Hetherington will write an article for the next Parish Notes on the project.
    - 7. SSEB have still not been contacted about them paying for a sign dedicating the recent tree and shrub planting to those Parishoners that gave their lives in the First World War. The trees and shrubs were provided by Scottish and Southern and the Parish Council planned and paid for the planting.
    - 8. It was suggested that the commemorative sign be installed by the War Memorial in the Churchyard rather than at Fiveways. This was thought to be a suggestion worth further consideration, and we will consult the Church and British Legion as to what might be appropriate.
  - ii. Cycle Path to Chinnor A Parishioner has written to the Parish Council, proposing a cycle path between Kingston Blount and Chinnor. Cllr. Hetherington is investigating this.
- **13**) Damage to Aston Green Footpath *Cllr Gibbons has written to the local stables requesting that they ask riders not to ride their horses along this footpath.*
